Above-mentioned product fulfils the harmonized requirements on plastic materials and articles intended to come into contact with food as described in the Regulation (EU) 10/2011 amended up to Regulation (EU) 02/2014.

No monomers subject to Specific Migration Limit (SML) are used.

No additives subject to restriction (Specific Migration Limit or Quantitative Maximum) are used.

Calcium stearate is approved as direct food additive. It is present, as additive, in the above grade.
